Millburn Township Committee Special Meeting Minutes

Minutes of the Special Meeting of the Township Committee of the Township of Millburn, in Essex County, New Jersey, held in Town Hall starting at 5:30 PM on the above date in order to hold a closed session.

Mayor Thall-Eglow opened the meeting and read the following statement:
