Dear Permit Holder:

In 2021, the Township will offer a Shopper Parking Permit for your convenience. Purchase of this permit will eliminate the need for you to pay for parking at the paystation, meter or have to use the Mpay parking application. Time limits will be strictly enforced.

**In order to obtain this permit, please submit the following with application:**

- ◆ A copy of the vehicle registration and insurance card.
- ◆ A copy of your most recent utility bill.

**The parking permit shall be placed in the rear window driver's side. See picture below:**



- 1. Business district residents are not eligible**
- 2. Time limits strictly enforced**

**The grace period for 2021 permit holders will expire on January 15, 2022. Vehicles parked with a 2021 parking permit after January 15, 2022 will be in violation and subject to summons. Grace period WILL NOT BE EXTENDED.**

(b.) \$52 for any additional vehicle beyond two (2) of a household

- ◆ A copy of the vehicle registration and insurance card
- ◆ A copy of a recent utility bill
- ◆ Incomplete applications will be returned
- ◆ **Make checks payable to "Township of Millburn"**
- ◆ Return completed application to the tax office or leave in the outside drop box.
